The bids were presented to the subcommittee as Bid A, B, and C so only the vice chair and chair knew who the bids belonged to. I have been in contact with Gil and Rosanne and they are very excited about returning to Colorado. They also sent some cd's of main speakers to be considered as main meeting speakers for our convention.

The committee also has begun to assembly a list of topics for workshops and marathon meetings. Each committee member brought 10-15 topics from NA literature which spoke to them, to be considered. F&E REPORT – May 9th, 2015

The pancake breakfast was a huge success. Thank you to everyone for their support.

A/V support: \$30 Church: \$350 Groceries: approximately \$620 (including sugar free syrup purchased the day of the event) Chair/Table rental: \$253.76 Total Expenses: \$1,243.76 (budgeted \$1,500) Total Income: \$1,549.00

I was told that the pancake breakfast last year made \$95.00 and this year we had net income of \$305.24. Please remember that this event also has income from merchandise and registration.

My vice-chair had a stroke of brilliance that I believe should be a guideline, or at the very least something that every F&E chair should do. And that is to send out thank you cards. I sent out thank you cards to the addict that managed our kitchen, the church for use of their facility, and the chair/table rental company which gave us a discount. I believe this is an important part of continuing to establish rapport in our communities and as an ongoing PI/PR effort. I went to the dollar store for these purchases and spent approximately \$4 including stamps. I covered this expense as it was not in our budget but will continue to send these out. Hopefully this subcommittee deems it budget worthy for future purchases.

The next event is the Movie in the Park which is on May 30th at 7:30pm at 3700 Baseline Road in Boulder. We will have 2 speakers, one of which will be Tina. The movies will be Star Wars and Fast Times at Ridgemont High. The facility is \$150 and an additional \$50 refundable deposit. We have been lucky enough to identify an addict with a very large popcorn machine that is going to donate its use (along with popcorn kernels and butter) so that we may sell popcorn. We will be purchasing additional theater-style snackage to sell. I am bringing my projector to show one of the movies and we will rent an additional projector for the 2nd movie. I believe that our subcommittee can continue to creatively stay under budget and hope this serves as evidence to our region in order to get a larger budget passed. Please remind addicts to bring their own chairs. I talked to the Boulder activities chair and was delighted to hear that the event was announced at their area along with flyers and Lakeside tickets.

We will be selling S'mores at the campout event June 19 – June 21. I have a campout flyer that I can forward via email if anyone is interested.

Lakeside is happening June 26th, 2015. Tickets are out. We sent tickets to the regional assembly and to the pancake breakfast. I plan on giving tickets out for distribution here and another round at region next week. Please continue to remind people that they need to get their tickets beforehand and if they don't plan on using their ticket, to pass it on to another addict.

We have had an addict graciously step forward to make the CRCNA quilt. Ally has done some sewing and has some relatives who are seamstresses. She has implored their help and they have obliged. She also sent me some pictures of other quilts that she has done. I am giving the shirts to Adam today to take back to her. I warned her that her willingness will mean that she will receive this request in subsequent years and she is still willing.

We need "artsy addicts" for the CRCNA event (art and talent show, DJs). We are working on generating a flyer and will send out once it's complete. I have set up an email (crcnaparty@gmail.com) that people can send submissions too and let us know that they are interested. I have had a couple of addicts (Bob D and Leah H) step up to help coordinate.

One thing that we still need to do is get the silent disco registration on the website. I need to talk to Autumn about this. The headphone fee will be \$2. Once we have that complete we will probably also start pushing flyers that have the CRCNA events outlined (art show, prom, poker, silent disco, talent show, game room)

I have seen flyers/tickets and heard announcements for events everywhere I go. GOOD JOB TO EVERYONE FOR GETTING THE WORD OUT. I really appreciate all of the help, please keep it up!
