F&E REPORT – April 11, 2015

Our committee has focused on preparations for the pancake breakfast. We are working with the treasurer to secure table and chair rental, along with the rest of the needed checks for the event. A grocery list has been generated, priced out, and reviewed by a capable addict who is helping to run our kitchen. Some girls from the Haven will also be attending and serving at our event. The next event in our queue is the Movie in the Park. We have started talking a contract with a church in Boulder that has availability on May 30th. They are getting some final answers for us. Once the contract is signed we will let everyone know the date, time, and location, along with flyers. I would still appreciate a contact from the Boulder activities chair – can someone please provide his number?

I have reviewed and approved the printer's proof of the ticket for Lakeside. I have a copy of that with me, if anyone else would like to review. The maximum number of tickets that Lakeside will print (without charging us) is 2,000. I went ahead and requested that they do the max. I do not have them yet and will follow up for status.

Can someone from Off The Wall please confirm that Jacob is still the activities chair? We need to start figuring out a facility for their event and I have not received a response from him.

We still need to identify a member to make the CRCNA quilt.

We need "artsy addicts" for the CRCNA event (art and talent show). We are working on generating a flyer and will send out once it's complete. I have set up an email (crncnaparty@gmail.com) that people can send submissions too and let us know that they are interested.
