Brenda E. has gathered a list of hotel costs (venue meeting spaces, refreshments & lunch). It would seem that my original budget estimate of \$ 350 for venue and \$450 for food/beverages (total of \$ 800) is low by several thousand dollars. Prices seem to be ranging from \$3-6,000 - way out of our league, budget and price range! At our next meeting we will be discussing alternatives such as a meeting hall with catering or perhaps charging a flat fee which would cover the costs of lunches - for it seems that we can probably cover the rest.

And as detailed in my last report, I contacted World. Their response is below:

Hello Linda – Thank you for writing to NA World Services. Your idea certainly sounds interesting. We do similar events around our World Convention. We invite professionals to attend sessions specifically

designed for them, and they often attend one of our main meetings as well. It has proven to be a great PR effort.

I can tell you that we do not charge those professionals for their attendance, we consider them our guests. On the other hand, payment for goods or services is different from accepting donations. As an example, we sell literature to anyone who wishes to buy from us, including non-NA members. But we will only accept donations from NA members.

So it would seem that your committee could charge for such things as meals, but you may want to consider if it is better to absorb that expense as a part of the invitation to the event.

Thanks again for writing. Feel free to follow-up with any additional thoughts or questions.

- 3. I am tentatively scheduled to attend the August Area PI meeting in Mile High, Off The Wall, and Boulder. I would like to attend the PR meeting of Pikes Peak but am unable to go up 2 flights of stairs as these meetings are held at the PPA ASO. Do the Pikes Peak RCM's have any suggestions for me?

I am pleased to announce that our speakers will be Carlos G on Friday night, Gina B on Saturday, and Bob G (stuttering Bob) on Sunday. Please pass this around and help support our conference!

Additionally, the band that was approved for Saturday night's entertainment is a 70's 'Show Band' with the big hair, lights, and funky down music! A costume party is currently in the works for this event and we encourage everyone to join us for the fun!

As you've heard, registrations are down a bit this year and need your support. So please pass the word and encourage overnight stays – as our agreement with the hotel is impacted to the number of rooms we book. The lower numbers were expected as we continue to recover from last year's hype, so your support and attendance is needed!

I have passed around the proposed workshop topics, and marathon meeting topics. Please look these over and let our Program Committee know your thoughts.

As you recently heard, our Merchandising Committee has experienced an issue with miscommunication and we need your guidance. The matter at hand is a verbal order from our Merchandising Chair, to another fellowship member acting as Merchandising Vice Chair and Vendor at the time. Both Marilou and myself were not aware that this member had been serving as Vice Chair at the time, but the matter will be brought to bear at their next committee meeting to address conflicts of interest and the neglect of due process and written contracts. Needless to say, this will not occur again.

But to briefly outline things and timelines. An original order of pre-convention merchandise was ordered correctly through bids, delivered and sold at functions. At a later point in time, the Merchandising Chair verbally requested x number of more shirts. This order was misunderstood by the member (vendor), and several more shirts were delivered than the Chair thought was ordered.

When the invoice and shirts arrived, the Merchandising Chair refused the order, claiming that the quantities were not what she wanted. At the time, I was en-route from Phoenix Arizona to Philadelphia – but was able to arrange a special fact finding meeting with both members. I was able to telephone in and our CRCNA XXI secretary was there to record those details (attached and read aloud). A total of 234 shirts were generated under this misunderstanding, where only 72 were apparently intended. The Merchandising Chair has agreed to approve \$641.93 for the 72 shirts, leaving a balance of \$1186.51. Again, the matter of due process, conflict of interest, and written bids have been addressed in the special meeting with appropriate chastisement. But your guidance on how to handle the remaining balance is needed. We can discuss this matter now, or under new business.

Though this has been a stress to the committee, we are all still looking forward to a great convention, with awesome speakers, and great entertainment! Please get your registrations in as soon as you can!

Special CRCNA XXI Meeting

On Thursday July 12, 2007 we had a meeting in regards to a miscommunication on an order of XL shirts. The meeting took place at the Village Inn on Chambers and Colfax at 6:00 PM. In attendance were Mel T., Johann Mc., Marilou L., Denise S. and Jay B. via phone.

First in discussion was in regards to water bottles ordered with Mel's company that have not yet been delivered. Mel stated that UPS had attempted delivery 3 times at Johann's home and that she was to pick them up in Commerce City at the UPS hub. Mel is to email Marilou and Jay the UPS tracking info to follow up. In conclusion the decision was made to have the water bottles delivered to Jay's work to avoid any further problems. It was agreed that we will cut a check to Mel's company for the cost of these bottles on Saturday July 14, 2007 at the CRCNA XXI monthly meeting.

Marilou then read part of Merchandise Committee's guidelines where it states that there is supposed to be a contract between CRCNA and its vendors. There has not been a contract between Mel's company and CRCNA. Mel explained his version of what took place in regards to the 234 shirts ordered vs. 72 shirts that Johann had intended to order. Mel states that she ordered 12 shirts of each XL size, color and style. Joanne states that she order 12 of each color of Men's and women's in multiple of sizes to be included in the total of 72 ordered. It came to the conclusion that this was a misunderstanding between the two of them. Johann needs to get everything in writing from now on to avoid this situation again. Mel was asked to do a spread sheet for the cost of the shirts that Johann had intended to order and CRCNA will pay that, but the rest of the balance will have to go to the Regional Assembly. Johann was asked to give all bids and paperwork copies to Marilou before July 22, 2007 Regional Assembly.

In conclusion the CRCNA XXI committee will pay Mel's company for the Team CRCNA XXI shirts and water bottles on Saturday. CRCNA XXI will also pay for the intended order amount of the XL shirts after review of spreadsheet from Mel.

The monthly meeting in the Boulder County Jail took place on June 27th with three H&I volunteers in attendance.
