Attendance

The only group actively taking part in the past two months at the area business meetings has been South Side Survivors. However I'm happy to say that at the July area meeting there was an increase in interest and attendance from addicts in the Pueblo area. This led to some rotation of service and the election of new trusted servants. This also boosted the moral of those who have already been serving!

PR Committee Report

I spoke with PR for the Pikes Peak Area about a meeting that is currently being held at the State Hospital. There was a concern because efforts to reach Brenda, the SCANA PR Chair, had been unsuccessful. I had a conversation about the meeting at the State Hospital and expressed that I wasn't sure that the SCANA had willing addicts capable of supporting the State hospital meeting, but that ultimately contacting Brenda and bringing the topic to the ASC should be the priority. I then reached Brenda. At the last ASC meeting Brenda reported that she had spoken with the Pikes Peak PR, and that the Regional PR and Pikes Peak PR had some issues to work out and that she was waiting on this process.

Sage B. the H&I chair reported that the meeting at the women's crossroads facility was going very well. She reported that another woman in the fellowship had gotten involved and now three ladies are carrying the message into the facility.

The Pueblo Pride Fest is happening in August and the SCANA has committed to man a booth for the day. As a result of this and in order to prepare for the day, the SCANA will be holding a PR training Monday July 22nd.

The 2013 Colorado State Fair is fast approaching. My efforts to get addicts in the Southern Area to attend the regional PR meetings have not accomplished much. IX CNAC REPORT

X CRCNA XXVII REPORT

Greetings from your CRCNA 27 committee,

Already eight months have gone by since you elected us as your administrative committee. And in just 10 weeks or so we will be gathering in Keystone for our 27th annual convention. Today were scheduled to review not only the workshops and marathon meeting topics for this convention, but decide on where you're 28 annual convention will be held. Lots of CRCNA business to do.

Hotel and Hospitality: First, please clarify to one and all how important it is to reserve your room at the Inn at Keystone. As of Friday, July 19 we have booked 199 rooms of our 225 rooms of which we are contractually obligated. As it relates to The Inn at Keystone, there are only about 20 rooms left.

Members of our fellowship who wish to be in the host hotel should book those rooms as soon as their resources permit. The Lodge and Spa has adequate rooms currently available with over 90+. And of course there are perhaps 100 condominiums in the surrounding area at our disposal. Housing will not be an issue but options will soon be limited.

Registration: As of our committee meeting held July 13, 203 registrations have been processed. Furthermore, 104 banquet dinners, 69 breakfast, 65 T-shirts, and newcomer donations totaling \$429.00 bringing total income to over \$9000. I understand that both our room reservations and registrations are currently ahead of the last few years. Of course the final numbers are what count and more will be revealed. I'm sure that our treasurer will provide more information on our current fiduciary condition and may also have insight the last few years and how they trended.

Fundraising and Entertainment: As many of you may know it takes a village to put on events. In all my years of experience with NA service, never have I seen the committee more united and committed in the execution of their responsibilities. Not only do they put on well-organized and profitable events, but attendees seem to have a lot of fun. Final numbers from Lakeside will not be available until their administration cuts a check for ticket sales. But the early numbers indicate a profit of \$700 on F&B alone. Our next event will be the 27th of this month and Frisco Colorado at our disc golf/picnic event. Rumor has it, it's been a little hot down here in Denver so please join us on the 27th in the cool and refreshing Rocky Mountain air.

Information and Web: If it were possible I would nominate Spencer as chair emeritus for this committee. Spencer has teamed up with, or more accurately given the task to Greg G. our print and display chairperson to develop and launch a mobile app for our website. As we become more electronically mobile our website has become virtually useless for those who use a mobile device. Phase 1 of this redevelopment is well underway. At your convenience access our website either directly or through the regional website and check out the new home page. We've designed it with large buttons to access the individual links you need. The next phase will be to redesign the linked pages in a mobile app friendly format. More will be revealed. As it relates to the short-term, we will be adding a button to the home page taking you directly to our convention program for ease of navigating workshops at our convention. Please visit our website and provide some input in September should there be something you notice or would like to see developed.

Merchandise: As of our last event merchandise is nearly sold out of our "Keep Calm Stay Clean" T-shirts. They have recently gone to production with our next shirt. Our logo on the back in black and white and across the front "Hug Life" a play on Thug Life. (for any of you non-gangsters)The plan is to have those shirts available for our next event on the 27th. Our merchandise committee has undoubtedly thought outside the box and has some new and creative ideas. I'm willing to bet you won't see, the same old stuff at the convention.

Programs: We're joined today by Patrick G. our program chair as we submit workshop topics and marathon meeting topics for your consideration and approval. Bear in mind some of these workshops are still under construction as it relates to their implementation. I.e. our campfire meeting. Whether we have an actual campfire or use fire pit etc. Notably our topics have been derived largely from our "Living Clean" literature. In most cases there will be four workshops simultaneously. Roughly still the same number of workshops however spread out in a way that gives our conventioners an opportunity to enjoy fellowship as well as our message of hope and freedom.

One addition would be our Saturday noon Newcomer's Workshop. I'm personally am very excited to include members of our fellowship with one to three years clean time, who by all accounts seem to be working a very aggressive recovery program and receiving the benefits of their efforts. These three individuals will speak for approximately 15 to 20 minutes each. The person with one year plus will speak specifically to the first step. The person with one and a half year plus the second step, and so on. Patrick and I will be very actively involved in the administration of this workshop/speaker panel. Although still in development, our hope is to attract the younger members of our fellowship and engage them in a more aggressive personal recovery program based in our literature and step working guide. All that said, we respectfully submit our program and marathon meeting lists for your consideration and if you have any questions we will be happy to answer to the best of our ability.

CRCNA 27 is coming together rather nicely. Financially speaking, our F&E committee has been doing a wonderful job putting on great events and raising funds. The bank account is currently at \$11,084.39. I have the most recent statement and bank reconciliation available upon request.

XI COLORADO REGIONAL CAMP OUT COMMITTEE REPORT

The ending account balance is \$1,470.36. Based on the decisions of last year it would be our recommendation to donate \$470.36 to region. I have added a comparison of last year to this year regarding campout debits and credits. Pre-registrations increased by \$286.18. I believe that this increase is due to the technology upgrades (i.e. paypal/on-line registrations and Square). Funds taken during the event (including 7th tradition, registrations, and merchandise) decreased by \$107.77. I believe that the decrease is due to the fact that there were a lot of Facebook rumors that the statewide fires were making for hazy camping. Total expenses increased by \$527.75. We had the added expense of \$175.00 for firewood this year. An additional \$330.54 was spent on merchandise. The donation to area decreased \$349.34. The additional funds spent this year equals \$527.75 which means that the total campout funds increased by approximately \$175.00.

XII H&I REPORT

H and I met on July 20, 13. There were H and I area chairs present. Our regional PI and PR chairs were there as well.

We went over the proposed budget, and it was approved by H and I committee. PR met after and the budget was given to PR chair and discussed. It will be proposed at regional on 7.21.13

We also went over what we had in literature, which is not much. PR has some extra Fellowship and Development literature. She will ask region if she can allocate that to subcommittees.

AREAS

From what information we have, there seems to be only three areas in the Colorado region that have acting committees and chairs: Boulder Area, Off the Wall, and Mile High. I did have some correspondence with someone from the Pike Peak area on 7.21.13. Pikes Peak has a PR umbrella and an active committee for H and I. But there is not a chair. They are functional and going into a detox facility.

I got an email from a member of the Together We Can Group in Mountain High. They are the only group running in the area and decided to dismantle the area. However, there are members of the group who are cleared to take meetings into Routt County Jail. They are running a meeting on Monday nights. There are six pods in the jail, and many inmates have been asking for some JFT's. The member I corresponded with requested 6 JFT's, one for each pod. Regional H and I will get those books for the facility.

Boulder seems to be doing well. They currently have meetings in 5 facilities and have 18 meetings a month, with about 35 H and I members serving. There are some slow meetings and some meetings that need chairs and some support. They are looking to start a new meeting for men and women at the Broomfield County Jail in August. The CD Library they implemented a year ago at the halfway house and a detox facility is still going well. People check them out regularly at the halfway house.

Off the Wall is also doing well. We currently take meetings into The Larimer County Jail Men's and Women's, both every other week. In Greeley, they have not been able to get back into the Weld County Jail as getting clearance is difficult. They take meetings into North Range Behavioral Health Detox and the Treatment at North Range. They also have meetings in Weld County Work Release and Platte Valley Youth Correctional Facility. They have about 20 trusted servants. The chair's term is up in Nov, so they are currently looking for a vice-chair. Mile High needs support especially for Jefferson County Jail. They have a training every month and the next one will be August 4th, 2013. They are also going to have a book drive to meet literature needs for the facilities in the Mile High Area.

DOC

DOC coordinator is working towards having all the DOC facilities we have relationships with to be a part of the WORLD CALL!!! This will be a first in the history of the Colorado Region! The DOC facilities will participate at CRCNA XXVII this year in Keystone and hopefully this will be through video conferencing.
