NAWS March 2023 Conference Participant Web Meeting

- Translation was available in Farsi, Japanese, Italian, Portuguese, and Spanish

- NAWS inventory has been moved from the adjacent warehouse space to a new storage facility in the Greater Los Angeles area, the move is complete
- World NA items for giveaway are to return to our region to be used within our NA communities,
 I have ordered boxes shipping items back
- During the WSC we will not be given paper copies but will instead have a link to a portal with all
 documents that we need during the WSC. They are asking that we each bring a device to access
 documents (tablet, phone, laptop). If you don't have a device contact NAWS so they can help
 you out.
- For those attending in person, masks will be required in the large group setting and them breakout rooms.
- WB asks to test day before we leave (take picture with your phone for verification). Then take covid test on day 1 and day 3.

- WSC will provide 2 covid tests upon arrival. If participants are not able to do this, they will be able to access from zoom during the WSC.
- If someone has symptoms or tests positive, they will be asked to participate virtually from their room.
- If the RD is participating virtually, either from their room or home and the AD is in person, only the RD will have access to the voting tool.
- The two-year budget, for 2024 and 2025, would be voted on during the conference. If the CAR
 motion to try a three-year cycle passes, a one-year budget would be offered for approval at an
 interim conference meeting, as was the case in this past cycle. There were also several CAT
 motions regarding processes that would be offered during the conference and decided on by
 CPs
- Business sessions will be during the hours of 9am until 5:30pm PDT
- Wednesday afternoon is not scheduled off this year
- The WSC will be streamed on YouTube
- If being reimbursed for transportation and need to pay for a ride, will only reimburse economy shared rides
- At this time, 40 delegate teams are fully funded and 14 are partially funded
- During the WSC we can schedule time to meet with WB members
- The list of nominees for elected positions, World Board, Human Resource Panel, and Cofacilitator members, will be distributed shortly
- In the spirit of cooperation, we are being asked not to have any submissions for elected positions on the floor of WSC for this cycle
- Each zone is being asked to put together a 5 minute video that will be played during the WSC.

Conference Agenda Report, Survey, and Conference Approval Track

Colorado Region held a CAR/CAT workshop with 2 NA World Board members facilitating on February 18th from 10am to 3:30pm. The WB members were Michael from Tennessee and Hammed from Kuwait. We had members in attendance from Florida, Alabama, Pennsylvania, South Dakota, Arizona, California, along with RCM's, Area Facilitators, and other members from the Colorado Region.

The workshop was very well facilitated and was instrumental in providing the knowledge needed to understand the materials in the report. We extended the workshop time to best cover the CAT and answer questions.

Our member from the Boulder Area compiled a submittable tally sheet for the Region which includes the 25 motions from the CAR along with the CAR Literature Survey. The Literature Survey will be removed the evening of March 31st and submitted to the WSC on April 1st.

The CAT is not attached to the tally sheet. The link to the CAT is the same as the CAR at the top of this report. It includes 6 project plan approval questions, NAWS budget approval, and the 2023 only: terminology for straw poll and vote outcomes for WSC, procedure for CP appeals toward CoFacs, the elimination of abstentions, and how to approach New Idea Discussion.

I have attended 5 CAR workshops, 4 of them included the CAT and have been on several discussion panels where we've gone over the CAT. Russ and I are glad to discuss any questions with your Groups or Areas. There will be a lot of discussion at the WSC about the CAT motions and best practices for Narcotics Anonymous. If you would like, please feel free to email us your input and questions to take to the WSC in regard to the CAT.

All additions made to the Fellowship's recovery literature, trademarks, service marks, copyrights and all other intellectual property by Narcotics Anonymous World Services, Inc. shall additionally be considered property subject to this Trust. However, note that NA service handbooks and other service materials approved by NA's World Service Conference are specifically excluded from the purview of this Trust.			
	Recovery literature should be taken to mean any Narcotics Anonymous book, booklet, or pamphlet intended primarily for use by individual NA members or for use or distribution within the context of an NA recovery meeting. Only NA recovery literature is designated as Fellowship Approved. Service materials should be taken to mean those materials intended primarily for use within the context of an NA service board or committee.

	 Changes throughout to update the references to WSC Boards and Committees to better reflect our current structure. The FiPT was written before the World Board was created. The suggested language in the proposed revisions describes our current system, not that of 1993. More consistent terminology to refer to the World Service Conference (WSC), Narcotics Anonymous World Services, Inc. (VIA World Services). 			
	 Two edits to Article 4, Section 12: Trustee Reporting Obligation on page 15 to change calendar year to each fiscal year and to add independent to the description of the annual audit. Changing representatives, conference participants, and RDs to delegates throughout. While all of these terms are widely understood in NA, this is a legal document and consistency in terminology is important, and conference participants has no clear legal definition. 			
	 Correcting errors by adding the word the on page 24 and other edits on pages 15 and 31. A change to the way the Inspection Clause is described on page 37 of the Reader's Notes so that the description reflects the changes suggested to the Inspection Clause itself.

	This bulletin has been largely rewritten. A clean copy of the bulletin with proposed revisions is contained in Addendum C. A copy tracking the proposed changes is included in Addendum D.			
	A summary of the proposed changes to Intellectual Property Bulletin #1 includes: Permission would be required to reprint book-length pieces. Current policy that was not clearly expressed in the bulletin has been added to the text. Groups are only allowed to reproduce currently approved versions of recovery literature, as that is all that NAWS is authorized to publish and distribute, and this permission does not include electronic or online formats. The introduction has been rewritten and the section on copyright has been moved ahead of the section on trademarks. Some copyediting changes are suggested, such as using the term policy throughout the document, rather than a mix of policy and guidelines.

If any of your Groups or Areas are asked for a Certificate of Liability Insurance for events you are holding, please contact CNAC or the Regional Chair. Give us the name and address of the facility that is requesting, and we can get a Certificate of Liability Insurance naming the facility. These are some of the main functions of CNAC. I plan to have myself and other board members provide information about CNAC and its service to the fellowship at future Regional and Area events. Greetings,

The archive material from Allen and Rosalinda's garage have been moved to a storage unit next to the current CRSC's storage unit with lots of helpers from the Dopeless Hope Queens group. Many thanks to Mike P. for getting the storage unit secured. Allen included instruction for setting up the display's, a video on making new display boards as we add material and an inventory of what we currently have. They wanted to pass along a few things they have learned along the way.

\sqcup They feel like displaying the items every five years is a good interval. I was surprised to learn
that people seemed to lose interest when it was displayed yearly. I personally wouldn't mind
seeing it every two to three years.
☐ They wanted us to remember some of the items are fragile, valuable and irreplaceable, so
please let's pass on the need to respect it's legacy.
☐ They wanted to remind us that when displayed it should be in a place that can be locked
when there is no one to monitor it. It has been co-located with merchandise, which they found
a bit chaotic but not impossible.

□ We decided it would be best to roll the archive tasks into existing positions and guidelines rather than create a new position and structure. Primarily because so many positions go unfilled, we would hate to see this get lost in the shuffle. A position with very few tasks on off years seems likely to go unnoticed. It seems like the Vice Chair of CRCNA is the best place to add this task. They are on the committee for 2 years, so their continuity allows them to handle the tasks their first year and mentor the next Vice Chair. Their task list is also more open. The vice Chair is not expected to do the display but be responsible for finding and facilitating a few addicts in the years that the archive is displayed. There are a few changes needed to both the

CSRSC and CRCNA guidelines. Green text is the current guideline wording, highlighted texts are the proposed changes.

needed. Ensure the instruction are visible to anyone who enters the storage area.

PROPOSED CRSC GUIDELINE CHANGES

In regards to CRSCNA guidelines, it seems best to assign the Archive storage shed accountability to the Region instead of CRCNA. It is likely the Archive storage will also be the location for all CRSCNA archived paperwork. That would require the following changes: Pg 15, Article 9, section B, bullet 2 Note this may not be needed but included in case others see it differently. The PO Box and two storage sheds will be an automatic disbursement when it occurs. All CRSCNA check disbursements should be made to organizations, businesses, etc. rather than to an individual addict wherever practical and approved by the CRSCNA. No reimbursements will be made without a receipt and/or CRSCNA approval Pg 24, Article 11, section B, bullets 2 and 3 CRSCNA shall maintain a storage shed for archives and CRSCNA, CRRMCO and WRCNA material. Storage shed keys to be held by Regional Chair. CRSCNA shall maintain a separate storage shed for the Regional archives. Archive storage shed keys to be held by Regional Chair and CRCNA Vice Chair. CRCNA shall maintain a separate storage unit for CRCNA material. Storage shed keys to be held by Regional Chair and CRCNA Chair. Teresa K.
