NA World Services Meeting Finder

Attached is the description of the new meeting finder which will be on the na.org website and the necessity of finding a new way to provide a more accurate way to find meetings in our Fellowship.

Also attached is the spreadsheet sent from the World Board member, Lori, who is heading up the meeting finder. If you watch the video of the meeting finder workshop, this gives a very good description of what they are looking for and why.

RCM's please reply back to me (not the NA World Board) with the center point, city or zip code, of your Area along with and corrected phone line and website information. The deadline to send this back is 20 December 2023. **Please only reply to me and not to this entire email blast.**

Notes for working with Phoneline - Website File

Below is a description of each column in the spreadsheet and the data needed.

Committee: This is the way your service body is listed in our database. (an asterisk after the name notes the region is not seated at the WSC)

Type: This simply indicates area, region or zone.

Current Description: This description includes the name of your service body and can have an indication in parentheses that highlights the geographic location. For example, "West End Area (West San Fernando Valley)". If this is blank, we do not have a listing for that committee.

City: This is the one we need to have added for all the Area listings in our database and is the driving factor for tagging your service body for the result listing. Please add one city that is in a central portion of your service body. We understand that many service bodies encompass multiple cities and broad distances, but the search result radius will use the pinpoint that you specify to help in identifying your service body to that area. If your area encompasses two states, there will be two listings even though the phone number or website is the same.

State: Please specify the state in which your service body resides. Again, if your service body resides in more than one state, please include a separate row for each additional state. In this case, choose a pinpointed city for an area listing.

Country: We should already have accurate information in this column, but please verify.

Website: This should be your current service body's website. A full web address is desired, not shortened pages. For example, "https://www.na.org" rather than "na.org".

Phoneline: This should be your information or helpline including the necessary country code for dialing the phone number. Please do not use an individual's phone number.

Phoneline 2: This field would specify a second phoneline number. In some instances, you may have a toll-free number and a local number. Please do not use an individual's phone number

Office: This would be a phone number associated with a service office, if applicable.

WhatsApp: Many of you have started using WhatsApp for an information or helpline number and you would put that information in this field.

Encompassing Committee: This column has the information for the service body within which your area or region resides. For instance, for an area, this would be the region the area is a member of. Or for your region, this would be the associated zonal body.

Note: A comment for you to read (if applicable).

We thank you in advance for taking the time to complete this information. Please let us know if you have difficulty opening the spreadsheet with your data or if you have questions.

Regional Delegate Alternate Report 11/17/23

Since being elected at the September Regional Assembly I have had a brief introductory conversation with the Colorado Region's World Board Liaison, Michael B from Tennessee. Kathleen helped me get on the list as the official RDA and have been reviewing the online materials from the 2023 World Service Conference (WSC). I attended the Rocky Mountain Zonal Forum (RMZF) meeting on Sept 23rd where I met many of the other trusted servants in the zone and we discussed possible services the Zonal Forum could provide. I also attended the WSC Conference Participant (CP) Webinar the same day. We reviewed the Environmental Scan Survey and the changes to the meeting finder.


I notified the RMZF about the video recordings that Colorado Regional H&I created. There are currently over 30 video recordings of speakers available online at https://nacolorado.org/hispeaker-videos/ These were created to be used in place of in person H&I meetings and are now available to the entire fellowship. The Southern Idaho region is interested in using them. RCM's please make sure your local area H&I knows about these.

I completed the Environmental Scan Survey for the Colorado Region. I provided forms for individuals to fill out at CRCNA and compiled the results which are attached at the end of my report. We had about 15 people provide feedback. I also provided printouts and QR codes to direct members of the fellowship to some of the projects and issue discussion topics (IDT) for the coming WSC cycle.

I have reviewed the upcoming surveys and IDTs, H&I Basics Survey, Gender-Neutral and Inclusive Language in NA Literature, Dealing with Disruptive and Predatory Behavior, and the Focus Group Volunteer Form. I plan to fill the volunteer form out myself after the next CP Webinar. I will work with our RD to get all this information out to the Colorado fellowship. I also attended the RMZF and WSC CP webinar on Saturday Nov 18th. At RMZF we decided to support the US Collaboration of Zones moving forward and planned upcoming meetings for the coming WSC cycle. At the WSC CP Webinar we discussed the Reimagining and Revitalizing Service Committees IDT and the 2024 World Convention. Registration and hotel rooms will go on sale before the end of the year.
