### Area Inventory Ad Hoc Report for June 2024:

- We continue to discuss guidelines revisions. Our list of changes is growing faster than we're getting things revised, but we are making good progress. Please join us if you're interested in contributing.
  - Fordyce - Working on further presentations and updating Guidelines to represent what has been voted on in previous recent years.
  - Elizabeth - many guidelines have not been revised since the early 2000's. Revising those are up to each Subcommittee. PR and Phone have been updated recently. They encourage and offer assistance for other Subcommittees to revise theirs.
  - Our next meeting will be Monday, July 15th from 7-8:30pm. The zoom link is on the website calendar.
- Predatory Behavior

- Please contact Elliot @ 303-324-1000 to get involved. They are in the final stages of approving literature.
- PR Chair - Jessica nominated. Very qualified, but does not have the suggested amount of clean time. Many perspectives around suggested clean time and why we have it to protect members with less than 2 years clean so they can focus on their personal recovery. Another member offered to be nominated for Chair next month after talking with his home group. Jessica offered to step down and wait till next month to be the vice-chair if open.
- Proposal - that the GL code in the meeting list is inappropriate. Proposing it be changed to LGBTQ. He just needs the go-ahead to work with the website committee to get it to fit onto the allowed lines on the printed meeting list, on the same lines it is already on.

**Treasure Report:** Elizabeth

- She will email full report
- Audit still in progress.
- Started a new bank account in 2022 and that is as far back as the audit can go. There have been many signs that the Guidelines have not been followed regarding many areas. There are checks with no notes as to what they were, there are numbers that do not match between what we reported versus what was deposited. There is still a long list of things to follow up on, and will report back once she has more thoroughly looked into these matters.
- The Treasurer will need much more oversight and accountability going forward.

**New Business:**

- Proposal Surrender to Win - concerned about GSR policy of voting at Area does not meet concepts 1,2,6. They feel the groups don't have a voice when we propose things and Area votes on them the day of.
  - Elizabeth - GSRs - the way you bring things back to your group is GSR holds a Stand Aside vote so we can report back to the group if you do not feel confident. So this is a matter of understanding the voting process and knowing your options as a GSR.
  - Chris - I will read the Concepts we are concerned about. I do not make decisions for my group. I only represent. I do not vote for them, they need to vote.
  - Heidi - but that is in fact the point of a GSR. Just as I do as an RCM. You are voted in with the confidence of the group in order to represent them by speaking for them and voting for them and the group's interests. If a large enough percentage of GSR's do bring up that they do not feel confident without consulting their groups then we do put a vote off for a month.
  - Brian - Be a voice, not a decision maker.
  - Chris - I will not be voting for my group as they need to have a say.
  - Elizabeth - as a GSR the point is that you represent the group. This is a difference of how we understand and interpret Concepts. The same as voting a Block - the Area body must vote on the Concept used to vote Block on any matter. We must continue business the month that it is brought up.
  - Jan - STW was largely concerned about changes in budgets, requests, and large money matters.
  - Heidi - Time sensitive matters are often brought forward. Such as the Men's Breakfast. There are a few matters we can afford to defer to another month. But there are many matters that get brought up where the GSR is given the capability to make immediate choices to represent

their groups. There are matters where you have the option of taking it back should you use Blocks and Stand Asides and the group conscious as a whole will decide. This is in place so that no one group blocks everything from proceeding.

- PR did not begin working on Pride early enough and missed sign-up for the non-profit booth slots. Other available spots are \$3,000. This had not previously been brought to the attention of the Area Body to ask for out of budget dispersal or assistance with fundraising. We were not able to participate in Pride this year.

- **Colorado Regional Convention of NA (CRCNA) XXXVIII**

Hello Fellow addicts!

I'm very grateful to be here today. It's great to serve with all of you in our region.

CRCNA XXXVIII is going great. The committee meets on the second Saturday of the month at 9am. Every meeting will be available on zoom. August's meeting will be zoom only and then the rest of them will be hybrid. I will be looking for a space in south Denver to hold them and will make sure to get the info out soon. We will make sure to put this information on the regional calendar. We still have two open service positions for CRCNA XXXVIII. The open positions are Vice

Treasurer and Print and Display. As a committee we are also discussing the need to start looking for next year's committee members. This service commitment works best when you have a smooth turnover from year to year. Please be on the lookout for willing capable members and encourage them to get involved as soon as possible. We currently have Liaisons in the committee from the Boulder, Off the Wall, Pikes Peak, and Mile High areas. If your area doesn't have a Liaison yet, please encourage someone to step up. We have been assigned an event manager by the hotel. She is very pleasant and knowledgeable. I think that we are going to have a good experience with her. We met for another walk-thru of the hotel on 7/8/24. We feel like we have a better understanding of the space available and what we will need to plan a successful event. We have agreed with the hotel that the ballroom might not be big enough to house everyone for Saturday night. The hotel's solution was to have the banquet in the Atrium, which would have more than enough space to accommodate us, and then move into the ballroom for the main speaker. However, this would be an additional \$12,000 added to our already \$13,000 food and beverage minimum, which is not feasible for us. The hotel said they would hold onto the Atrium, and if no one booked it within two weeks of the convention, they would just comp us for the space. The committee has agreed that we would be going forward with the assumption that we would not have that space. We were able to increase the size of the hotel room block. We currently have 436 of 519 room nights reserved. Hurry and get your rooms before they're gone. Early bird registration ends July 31st. Please get registered as soon as possible. This aids us in our planning. Our merchandise is available to purchase online while you are getting registered. It is vital that we sell as much merchandise as possible before the event. If you wish to guarantee getting what you please do so ahead of time. We will have merchandise available for sale at CRCNA XXXVIII, but it will be a limited supply. The goal is to sell out and not have remaining inventory. This is necessary to raise as much money as possible. We have plans on adding a couple of items to the merchandise for sale. Please check back online for additional items. We have selected our main speakers and are working on the workshop speakers. We have sign up sheets online for your convenience. We have selected a merchandise print shop. Pine Printshop in Fort Collins will be our contracted vendor. We have decided as a committee to charge one price per item this year. There will not be an upcharge for larger sizes. Our committee has been really driven to be all inclusive. We will be striving to achieve this goal to the very end. We have 3 upcoming Fundraising events. We had a 4th event planned for the end of this month, but the host area has backed out. We have a flyer available for the event in September and I will be bringing flyers to the other events to the September assembly. The event taking place in September will be happening prior to the September assembly. I will send the flyer to the region as soon as possible so that the areas get in a timely manner. The Fundraising and Entertainment committee has been hard at work planning. We have some fun exciting events being planned for this year.
