RE: Feedback on the 2018 Colorado Regional Convention of NA

The Ties That Bind meeting of the Boulder Area of Narcotics Anonymous (NA) would like to express that overall, we thought the 2018 Colorado Regional Convention of NA went very well and was successful. However, we would like to express some concerns regarding the Saturday Night Main Speaker Meeting.

- 1) We thought it was disorganized and failed to maintain the audience's attention. As a result, many people became restless and started talking during the meeting. It made it difficult for other audience members to hear. The poor sound quality also made it difficult to hear. In addition to the chatter, many people stepped outside to smoke. The smoking occurred so close to the outside doors that the smoke overpowered the hallway.
- 2) We thought it was unfortunate that the main speaker's time was cut short due to the additional activities and disorganization.
- 3) We thought it was very inappropriate to have women from a recovery house do a dance in the front of the room during the event. Many women come into the program having been sexually exploited. We are here to help newcomers get and stay clean. Newcomers are not here for our entertainment. We respectfully ask that this not be a part of the program again:
- 4) We thought that the rapper mentioning that he was on "America's Got Talent" during the Main Speaker Event violated our traditions in that it pointed towards an outside endorsement (Traditions 6 & 10). It also suggested that he was prestigious and different from other addicts, instead of practicing anonymity (Tradition 12).

We hope the CRCNA committee solicits and incorporates feedback when planning future conventions. Thank you for your consideration.

CRCNA XXXII Closing Report December 01, 2018

I would first like to thank the everyone here and the NA body for the opportunity to serve on the Fundraising and Entertainment Committee the last 2 conventions. It has been an amazing opportunity to reclaim old skills, make new friends, pull together as a team, and celebrate the gifts that recovery brings as we carry the message. One of the biggest challenges we had was getting the fliers out to the meetings. The best flow of information was thru the Regional meetings. I would advise any new F&E Chair to prepare the next 2 months worth of fliers and pass them out in advance thru this meeting. I found at the area level there is an inconsistency with communication. That said, I realize there was a huge learning curve in understanding what activities are going to be successful within this body. With the support and diversity of the F&E Committee we pulled together and had a fun and successful weekend at CRCNA. The impact of attendance is not only the lost opportunity for fellowship but the part of this committee focused on fundraising. Overall we were conservative spenders and our efforts with things like F&E items and Give Away Drawings offset the end total. I would like to include that we also were able to reach out to some areas that haven't had as much support. I was so impressed with the dedication this committee had and how many drove for hours just to host an event in the mountains. Watching that connection grow over the year was touching and seeing them at other events was so great. Other challenges in communication relates more to this committee and how that impacted things. The collection of passionate and powerful leaders this year set the stage for us to create a supportive dynamic team. That experience turned into a battle of wills, personalities came before principles, traditions often got thrown out the window, egos took hold, accountability was missing, respect, and courtesy were lost. The effects of this not only created a toxic environment it impacted the F&E budget, none of the committee will serve next year, and some are struggling with their recovery bc of lost confidence in NA leadership.

Here are the bullet points I would like to include because of the nature of some items I will not elaborate on them in this meeting. These were events just prior to and during CRCNA XXXII.

- I felt pressured and manipulated by the CRCNA chair to host an activity after being told I was, "Denying them an opportunity for service.". Which ended up costing over \$500 and directly conflicted with the planned event which doubled my budget costs and was not successful.
- After 2 conversations confirming I did not want any changes made to the listings in the program for F&E the CRCNA chair made changes and at the last minute I noticed them and had to have it changed again. When confronting him about the incident expressing how I felt betrayed, I was mocked, discounted and sent dictionary links for the word.
- The CRCNA chair arranged for my vice chair to use his truck and trailer for the golf cart without any communication leaving me to make several car load trips to prepare for the weekend.
- While I acknowledge having misplaced my keys and getting locked out of the storage closet is on me, the events following was unacceptable. The CRCNA chair was unresponsive on the radio or phone for over an hour prior to the events starting. Once found and was asked for the key he began shouting, swearing, and demeaning a committee member in a lobby full of people. This was followed by me getting yelled at and his refusal to help. After 25 minutes we were able to get and deliver the prizes event 45 minutes after it had started.

- As an experienced stage performer I felt having women in recovery asked to be placed in that situation was inappropriate because of what the nature of that includes. I was upset that the plan for that was not mentioned prior to CRCNA.
- It was distracting to have someone on stage while someone was talking.
- I was uncomfortable during the shout back reading of CRCNA titles.
- I don't think the rapper before prayer was discussed either.

It felt like the CRCNA chair lost sight of Traditions, Principles, and Guidelines as his will and ego took hold. It has been a challenging experience for me as I try to practice them and depend on the commitment we have to upholding them. To watch more than one member of this committee stretch themselves beyond the acceptable level of behavior had been the worst experience for me and some of my committee members.
