Meals have been determined. Final choices have not been set. Last year the break down was 250 dinners, 125 breakfasts. At \$35 for dinner and \$25 for breakfast we will meet our \$9000 F&B requirement. That includes 26% service charge.

\$9000 + 26% = \$11,340 F&B commitment

 $(250 \times $35) + (125 \times $25) = $11,875$ revenue

 $(250 \times $40) + (125 \times $30) = $13,750$ revenue

A/V invoice from last year was \$15,000 (\$11376 total, \$2730 service charge, \$1199)

\$5000 of that was for 2 front projections. I am proposing to not have a Projectors. It's a luxury item. We will be looking for quotes from outside vendors.

CRCNA committee decided to do away with line item for Banquet table giveaways. We will try it this year to see if the giveaways are important to banquet goers.
