These updates are not approved so we are operating from the original guidelines. These will need to be approved at the Regional Assembly in September.

program committee and then put any proposals for space and rooms to program. However, the input from H\&H is in the final form to be presented at the next regional mtg and then voted on at the September $21^{\text {st }}$ assembly in Pikes Peak area. The latter date is why the luau is to be held on the $14^{\text {th }}$ so as to not conflict. Returning to the ad hoc, I sent in an edited version to Eric with tenses and some grammar fixes. Hopefully, they will make the final cut before the vote. Also talked about the current treasurer excel spread sheets. I was told in no uncertain terms that it is not to be modified and that it works just fine as it is. I reviewed it with my daughter for a better understanding and got a current copy from Daniel to look over.

Will turn in a request for reimbursement for the $\$ 120$ to reserve and rent the pavilion for the luau. Sent info to Max for a flyer to be reviewed here, however that was delayed due to problems with the crena aliases.

Call(ed) in to the F\&E SC Friday night. Everyone please announce silent auction needs as we can collect that stuff to have a pile before the convention.

Contacted the comedian. Checked on another recovery related possibility in FtC. Is the contract for last year available so I can check it out?

I will get copies of the receipts/amounts of food that was purchased by Daniel and Brenda for the pancake breakfast and Lakeside so as to know what to buy next year. As well as for the luau. Paul I know the ASC was last Sunday but could you put out the word that we need another venue for the pancake breakfast? Heard that 2500 Broadway had held it before but has no chairs and tables.

Allowed members requesting it to join Crcnainfo. If I could beat Zach to the punch. Modified the timeline for current info (I think) and made it easier to read (I think). Brought copies so that everyone could have one. Main additions were adding elections for the next crcna - Exec com at Sept assembly and SC chairs in October. Whether that happens at our Oct planning meeting or another date and time is up to us to decide.

What we spent our monies on was $\$ 1173.00$ Brenda for quilt and Lakeside and $\$ 56.98$ to Daniel for Ice and Propane for the event. After all said and done we made 365.92 from the Lakeside event as a profit. We still have the ticket sales to get but that won't come till the end of the year.

We deposited $\$ 5736.15$ which $\$ 1145.90$ came from F\&E. $\$ 942.43$ came from Registration \& Merchandise from Lakeside and \$3347.82 came from Pay Pal. \$300 came back from the seed monies. On Monday I will be paying for the deposit for next year's convection which will be $\$ 2212.50$. If you have any questions feel free to ask. Deposit for next year is paid.

Pikes Peak Area - Colorado Springs Event. We will be working with Activities to help with the Mexican Dinner and Bingo event. We are planning for October $12^{\text {th }}$ from 5:0010:00. Speaker meeting at 7:00. Bingo to follow. Hoping to give away a registration for the grand prize winner of the final bingo game. Once I have the location locked in, I will work with Max on a flyer.

The DJ contract for the convention has been signed since we were able to lock in a good deal and were under budget for both nights. DJ Wellness/Sound off Colorado is the music for the convention. Friday night is a mixture of 80 's, Pop, and current music. Saturday night is the Silent Disco with headphones and equipment. This went over well on one of the previous CRCNAs. They play 4 hours each night and the cost is $\$ 2500.00$ total. Our budget is $\$ 3000.00$ so we are under.

Dave is handling lining up a contract for the comedian as getting bids has been taking a lot of time. He will be probably going with the bid from Paulie, which was a name submitted this year. We will need to discuss how to handle the comedian at the convention.

We will have two quilts for the "chance to win". The second one will cost $\$ 200.00$ and I
