It has been a busy month. I had to go back to the Hotel to negotiate our banquet pricing. After several phone calls, Dave, the hotel, and I had a conference call on 3/3. The result is that we negotiated a tiered pricing agreement, addendums to the current contract and the following two years. Our beef meal is 45.00, chicken and vegetarian are 39.00. Breakfast will remain the same at 26.00. I will be finalizing this within the next week. I attended the Registration and Program meetings this month. I was able to get on the phone with our registration committee. This committee has a good amount of support. It was good to hear the willingness to serve and I plan on attending this month in person. Program is going well. They are listening to speaker recordings and are getting closer to selecting our main speakers.

I also went to the church for the breakfast to give them our rental fee and to tour the facility. I was so happy I did as there was a communication error on their part. The result is that I believe we got a better deal. We will be setting up in the gymnasium. The entrance will be on the eastside of the building. We will have an industrial kitchen and will be away from the other event that will be happening. I will be picking up the necessary keys and a receipt on April 8th while I am in Denver. I believe we will be able to start setting up at 7am the day of our event but will confirm this by our next meeting.

As of this report the bank balance is now \$8,685.33. The previous balance as of 7/7/2020 was \$6200.53. Since then there were deposits of \$100.00 return of rent for the Pancake Breakfast less a disbursement of \$69.90 to Dave A. for the use of his wife's Zoom account for the last few CRCNA meetings. This also includes the \$2212.50 check that was voided for the May's deposit at Embassy Suites. That makes a balance of \$8443.13. our actual bank balance is now \$8685.33 because a deposit was made on 7/20 of \$242.20 signed by David, who I assume is Dave A. I do not remember or know what these funds come from. I confess I have encountered some confusion over some of the details in the treasury data due to the length of time I have not been engaged with the account. Its all good though as the bank account and the Income statement in the spread sheet agree. There is still \$232.88 in the PayPal account that I will leave in there until the committee decides what to do with

the online store. I will be required to attend the Regional Assembly with a report next week as well as the next CNAC board meeting on the 26th. I would like to have a final accounting of merchandise sold by that time to finalize this year's convention tax liability. I would like to request the web servants help with this by taking an inventory of the web store merchandise sales that I can compare with my own data.

Outgoing Chair report to Region for the record:

CRCNA XXXXIV Report to Colorado Region07/19/20

Having not met here in 3 months, it is amazing what transpired in the interim. We met on 05/02 and 06/06 and moved our 07/11 mtg up to 06/27. The latter was in response to the CNAC mtg held on June 20th where it was decided, along with the hotel, to postpone XXXIV until 2021, and extend the contract to be for 2021,2022 and 2023. I was recovering from knee replacement surgery and the mtg was not focused. What was decided is that all items, but merch would be pulled from the web site. Sales of merch will end 09/30 giving the committee time to order apparel and get it marked with the 2020 logo and theme. Items will be shipped to the members that paid to do that around November 1st. The committee will set up shop in Pikes Peak, Mile High and OTW areas to hand out such merch as can. Those dates will be announced later. Whether the same logo will be pulled forward is unknown at this time. So please announce these could be quasi-rare and unique items. We meet again on 09/12 and have a few things to talk about. Please announce that hotel reservations should be cancelled so as to not have rooms to be paid for this November. The hotel is working with us on that, but personal responsibility is best.

Since the convention is postponed, the annual H&I training is no longer in place. Unfortunately, we will be dumping that in Chris's lap for 2020.

We hosted 3 virtual events. Support from the fellowship was underwhelming. The first garnered @ 80 people, the second @40 people with almost 50 for the third. If you subtract committee members, speakers and such, those numbers are reduced by 20 each. We had some wonderful speakers and our expectations were such that we purchased the ability to host up to 500 people. That \$100 was compensated for by Venmo donations at least. Thanks to those few that contributed.

We announced a no refunds policy, but so far we have returned \$70 for 2 registrations. If people ask, other than for merch, we will try to be accommodating. Rolling over all purchases to next year is our favored solution. I also have a check for \$2212.50 which was to be our 3rd installment payment which I will tear up. We have a check for \$217.20 which was to pay for the NAWS historian to fly here to do a presentation which has been returned. There is an odd duck as well. A letter addressed to CRCNA had a check made out to Colorado NA Inc for \$25. I will deposit those checks tomorrow unless I hear otherwise.

At the June 27th mtg, members were given the freedom to step down or continue on with CRCNA through next year. Our Vice Treasurer and Printing and Display chair resigned. However, after much thought and cussing and discussing, I've decided to step down as chair at this time. Having a stupendous and amazing person as Vice Chair in Joann D, I feel that the convention is in great hands so there are now 4 open positions. Administrative members need to be elected here, but F&E and P&D can be elected at any regular CRCNA mtg. It has been an honor to again serve at the regional level after a long absence. Friendships have been rekindled. I need not be surprised at the level of energy and dedication I see here in all aspects of the body. You all have my utmost respect. I will turn the chair and F&E notebooks over to Joann as well as the key to the storage unit.
