Currently our open subcommittee chair positions are Print & Display, F & E, and Merchandise. Currently the only active Liaisons are from Boulder & Mile High. Please let the fellowship know we need a Vice Chair and a Vice Treasurer. The next regional meeting will be 01/17/21 via zoom at 10:00AM.

5 Dec 2020 CRCNA XXXIV Final Treasurer Report.

To make a long story short. CRCNA XXXIV began with seed money of \$10,000.00. We collected \$5,694.30. We had expenses of \$7114.42. That left us with a loss of \$1420.12 leaving us with an available bank balance of \$8579.88. Of the \$5694.30 revenue \$2825.10 was in Merchandise sales, \$312.00 was collected for shipping. Registration collected \$2324.20. F&E collected \$233.00. Of \$7114.42 in expenses \$4425.00 was for two deposits at Embassy Suites. Administration spent \$492.75. Merchandise bought \$1534.32 and spent \$427.35 on shipping, \$115.35 more than collected. The total taxable income this year was \$2825.00. Sales taxes on this came to \$235.00.

In the CRCNA XXXIV Budget, on page 5, it shows Merchandise budgeted \$50.00 for postage but after collecting only \$312.00 online it came to \$427.35 putting them over budget. I have no reason to believe this will not be approved in committee as per the CRCNA guidelines. Also, I noticed that the Hotel and Hospitality budget for hotel deposit is only \$5,212.50 but we have 5 installments of \$2212.50. This need not be a Hotel and Hospitality line item, since in the Financial Statement spread sheet it is listed under a separate detail in the Income Statement sheet.

In year's CRCNA XXXV budget all the line items for each subcommittee will conform to the line items in the Financial Statement subcommittee details from now on for simplicity. Otherwise, if a new line item is required

by any subcommittee it will have to be added by the Regional Treasurer. I cannot do it myself as I do not have the authority to do so.

Joann and I have discussed the possibility of donating money to Region from the profit that we have made. Yes, we made profit. This discussion centered on how we have already paid the first two deposits for the Embassy Suites which rolled over to CRCNA XXXV. That left us with a starting balance of \$5575.00 in the bank this year. Our available balance now is \$8579.88 leaving us with a surplus of \$3004.88. Joann and I think that the Registration and F&E amounts we collected of \$2324.20 and \$233.00 respectively, since they too roll over to next year should be exempt from this amount. That would leave \$447.68. This will be discussed in new business.

And a half bag of shipping bags.

As I said before I hope that the incoming chair reaches out. I would love the chance to share my experience with them. I would also be willing to participate on a limited basis on the merch committee. I would be happy to do my part to keep this method of production going if the committee sees fit.

In closing I want to thank everyone for their love and service to this fellowship. I know I would not be the man I am today if I did not have strong people like you all to show me how to be a productive member of society.
