Our beginning balance was \$8,049.88. We had \$4,873.00 income. Expenses were \$158.83 PayPal charges, \$4.00 in bank charges and \$115.00 to the Longmont City council for the permit and use of the park. I wrote a check for \$1,023.70 to West Press for Merchandise. That gives us an available balance of \$11621.35. Of income \$3,944.00 was from Registration Early Birds Dinners Breakfasts and Newcomer donations. F&E contributed \$135.00, and Merchandise was \$619.00.

Our first fund raising event is in a week and I am a little concerned about how funds are going to be raised. Are we going to be doing registrations and or selling merchandise? How is that going to be done. Will I have to go to the bank and withdraw money for making change and how much and in what denominations do I get? Are we taking donations also? Attached is your latest your breakdown:

Thursday - 16 rooms Friday - 101 rooms

Saturday - 104 rooms Sunday - 6 rooms

Monday - 1 room Tuesday - 1 room

Rooms are sold out on Friday night, but you still have 17 rooms available on Saturday night only.

We have set up additional room blocks with a few overflow hotels. Please see the overflow hotel options within the area.

We have room blocks at SpringHill Suites. 5 out of the 10 rooms are sold. We also have My Place in Loveland which at this time has no reservations reserved. We will contact Candlewood Suites and Holiday Inn (if necessary) but they require a contract. The first two hotels do not so we have contacted them first.

• The guest speaker rooms have been confirmed, Confirmation number 87963080. I need to put names on them unless Kathleen has already taken care of that.

I spoke with James Burton of AV at Embassy Suites. He received the Program (thanks Kathleen for meeting w me and finalizing the program) James and I spoke yesterday. He has been reviewing it. We have provided everything he needs to get us an estimate for our wants and needs. Once that is reviewed, he will get us a list of what is required. We are actively working on this project. We may still be able to offer the possibility of a local broadcast of meetings so that people can use their laptop and dial into meetings. This is something we could offer at the hotel.

I asked the Merchandise Committee to offer a special item or items for the table gifts. The discussion is that we purchase items for the table gift at cost to save money for other needs for my budget. I'm going to offer a different way of providing table gifts.

Next month is finalizing the AV budget and making sure we have names on hotel rooms for speakers. The table gifts will continue as well as working with H&I to secure the meeting broadcasts.
