**CRCNA XVI
Chair Report to CRSCNA**

January 12, 2003

In my November report to the Region, I turned over the profit earned from CRCNA XVI as a donation to the Region in the amount of \$15,388.30. In reconciling our books to our January bank balance, we have found that our book balance does not reconcile to the bank statement. I am in the process along with Tiffany J., Treasurer of CRCNA XVII, to find the accounting error in the amount of approximately \$1900. This means that CRCNA XVI incorrectly gave the region \$15,388.30, when in actuality, the profit was closer to \$13,500. I apologize for my haste in turning in the profits in November, as CRCNA generally closes to the January statement and usually makes its donation in January. As I would like to think that our committee put on a perfect convention, I am very embarrassed about the error.

Since this mistake was discovered just yesterday, the error is still being investigated. Tiffany and I (who are both CPA's) will go back and balance every entry from the books of CRCNA XVI to the bank statement. Although this is probably an accounting entry in error by CRCNA XVI, it could possibly be or an error by the bank. In either event, I want to make it clear that this does not appear to be a matter of missing funds, but rather an accounting error. We will find the error and report back to the Region as soon as we do.

In the meantime, I respectfully ask the region to set aside \$1900, since if it was in fact an accounting error, we will ask the Region to return the amount overpaid back to the CRCNA account.
