Discussion:

The world-wide workshop was an excellent opportunity for me to meet with the other zonal forum delegates as well as other regional delegate teams and start preparing for the April 2008 WSC. Some literature projects on the horizon: revision of In Times of Illness, and new IP speaking to Drug Replacement Therapies and Recovery.

Currently the National Institute of Health has classified the disease of addiction as a disease of the brain; as a consequence there are currently 60 projects in the popular media coming out in the next 2 years. The WSO has been swamped requests to speak to these issues and expects the requests to start coming in to our local service committees. I was hesitant to do more than even mention this, but after some consideration I have decided that a Medication in Recovery Workshop would be a better way to help our local service committees prepare for discussing this issue. I will need five willing participants to help me present this workshop. Due to the volatile nature of this discussion, I request that we place it early in the Regional Assembly agenda.

The Home Group worksheet was work-shopped and as presented, I believe that this is a valuable tool to assist our groups in serving our primary purpose.

## PI Report

Brenda E. (PI Chair from Pikes Peak), Torri F. (PI Chair from Mile Hi) and I met on May 5, 2007 @ 10111 w. 26th St. - Denver, CO. We reviewed the functions of CRSC Regional Public Information Committee: to support Area PI Chairs and to do Outreach/PI efforts for locations within Areas with PI Committees but not covered; to do PI efforts for locations within Areas without PI Committees; and to do PI efforts for any location in Colorado not covered by an Area.

Next, we discussed the development of packets for Area PI Chairs. Torri has accepted the tasks of coordinating Area PI Chairs and to create a CRSC PI contact list. We thought the Area PI Packets should include:

- a. Contact info form (name, loc, etc. of NA contact)
- b. How to find professionals / the public
- c. Form cover letters for contacts
- d. Tracking forms
- e. Copies of PR Handbook plus Basic PI Guide
- f. Mailings content: IP's (NA - A resource, white book, Newcomer, Am I an Addict?, Welcome) Flyers / posters / meeting lists  
Form letters w/web address & contacts
- g. Presentation tips: mailings, formats, dress, Traditions
- h. CRSC PI Contact list
- i. Regional Guidelines and possibly AGTLS

Then, we discussed the PI Blog on [nacolorado.org](http://nacolorado.org). We are asking Don or James to establish this blog for CRSC PI members and help us be able to use it.

Torri also is developing a Regional PI Database which will be online to aid Areas and to aid future PI/Outreach efforts for the CRSC. This database will include current info on the name of a facility, the type of facility, contact name(s), phone #'s, and the facility's address. Torri will be working with the CRSC Webservant to coordinate this monumental but so necessary task.

Next, we eagerly discussed Professional Regional Workshop to be held in early October of 2007 somewhere along the Front Range. This event will be a Professional "Learning Day" with NA and PI presentation sessions, lunch, and an afternoon session with Q&A's and ending with CRSC H&I panel in info as H&I efforts tend to follow PI into a facility. (Hopefully, CRSC will get an H&I Committee Chair today...) Brenda has accepted the task of coordinating this event. She is searching for a venue to hold 100-200 participants. We discussed the cover letters and flyers to be distributed for this event to the professionals (facility therapists, private therapists, court personnel, law enforcement personnel, educators/ counselors, and the like). We envisioned the event to grow to upwards of 1000 attendees in future years. This event will aid not only Area PI efforts, but can be used to reach those isolated folks so the CRSC is truly carrying the NA message to the still-suffering addicts who has yet to hear about NA. Linda is developing the budget for this event, She is working with Tom R. (NAWS Comptroller) to solve the issue of registration fees (to partially cover costs vs the Trads). Linda is also working with WSC/WSO to have World Board and World Service members in attendance.

Next, we discussed Outreach Activities and are bringing a Proposal for consensus at the July Assembly as this shift might affect the Regional Guidelines. This Proposal is to move non-Area outreach needs to PI. Historically, our RDA has attended to any Outreach efforts which usually involved Areas needing help, info and the like. This proposal will supplement these efforts by removing outreach needs in locations without Area coverage from the busy learning functions of the RDA. In the course of creating this proposal, we discovered that [nacolorado.org](http://nacolorado.org) does NOT contain any forms (like proposals) which could be filled out ahead of this meeting to be more cost/time effective. Could this lack change?

We identified some key issues that still need to be addressed and some key answers that need to be provided to the fellowship. It is our feeling that this work cannot be done in the time frame that we had originally set for ourselves. It is also our feeling that rushing into and through this process is not in the best interest of the fellowship of NA in the Colorado Region.

With that, we have decided at this time to withdraw the motion for approval of the Bylaws from the agenda for the July GSR Assembly and instead, try to answer the questions posed to us, meet with some professionals to seek guidance about the laws and tax implications that would affect us and also delve further into the possibility of purchasing event financial insurance coverage in lieu of incorporation at all. We intend to make another formal presentation at the July GSR Assembly.

As chair of the Ad-Hoc committee I would like to thank everyone for their open, honest communication and input.

#### **Boulder County Jail**

On April 25<sup>th</sup> the monthly NA meeting took place in the Boulder County Jail with three H&I subcommittee members in attendance along with 20+ inmates. They need readings and could use a few Basic Texts as well.

I picked up plenty of volunteer applications for GSR's to bring back to their groups and hand out if someone expresses interest after they make an announcement about H&I in their report. Applications can be given to me once they are filled out.

The one woman who turned in an application has been approved, so there are now **three women who are cleared**, two of which are able to commit to bringing a meeting in. This means if we can get one or two more volunteers we maybe able to start a women's meeting again.

**The next men's meeting is Wednesday, 30<sup>th</sup> @ 5:30 p.m.**

#### **Adams County Jail**

I spoke with the programs coordinator and had some volunteer applications sent to me. There was no NA meeting last month because one of the two volunteers currently willing to attend couldn't make it. This is what happens when there are only two members willing to commit to a particular H&I meeting. When one is unavailable, the entire meeting has to be cancelled, in this case meaning inmates have to go 60 days without a meeting of Narcotics Anonymous.

**The 2<sup>nd</sup> Wednesday of each month from 7:00 to 8:30 pm is when the meeting takes place. The next meeting is May 9<sup>th</sup>.**

There are currently around 1,300 inmates in the jail, 160 to 200 of which are women.

In order to volunteer, you need to fill out an application and, once it is approved, attend a 2-hour orientation class. The next class is scheduled for Tuesday, May 15<sup>th</sup> from 6:30 to 8:30 pm. The next one after that will be Tuesday, June 12<sup>th</sup>. They are usually held on Tuesday, but the programs coordinator told me if someone can't attend, for whatever reason, he will reschedule one specifically for that individual.

They need NA Literature, which I am including in my proposal.
