### OFF THE WALL:

We have the following events coming up: Dinosaur Days II BBQ potluck on Sept 26<sup>th</sup> from noon to 5pm hosted by the N.A. Nooner in Greeley. This event is featuring Jacqueline B and Joann D as speakers. Oct 3<sup>rd</sup> the Volleyball Shin-Dig BBQ will be held from 10am to 5pm at Rolland Moore Park in Fort Collins hosted by a number of groups in Fort Collins. On Oct 9<sup>th</sup> starting at 7:30pm we will be meeting at Fritzlers Corn Maze near LaSalle, CO hosted by Addicts Seeking Sanity. Flyers are available for more info. Our area was unhappy at the turnout at the Western themed dance and asked us to express this to the Region and this will also be addressed through our CRCNA Liason to see what changes can be made to help make this a more successful event.

We continue to serve 6 facilities regularly in our H&I efforts. We have started taking meetings to Summitstone, it was well received and hope to have a Panel Coordinator in place to add to our lineup. We have lost our Panel Coordinator for Platte Valley Youth Services and had no meeting last month; we are hoping to get a replacement so we don't lose this facility.

We set up a booth in Sterling, CO in front of the courthouse during a community drug recovery awareness event that included a small presentation about N.A. and local meeting information. This event was attended by the Mayor, clients from Advantage Treatment Center and the halfway house, attendance estimated to be upwards of 100.

We recently elected Shane R as our new Merchandise chair and are grate to have him as this position had been open for some time.

### PIKES PEAK:

Good afternoon. Pikes Peak has asked me to request a re-vote for the H&I position. In July, there were 22 voting members present. Since only one person ran for the position, 2/3 of that number was needed to approve the nomination. At the meeting the Chair announced that there were 12 in favor, and that was all that was needed. Gene was told he had been elected and we moved on. After the meeting I contacted the Chair twice asking for clarification of the numbers. 2/3 of 22 is 14.5, 2/3 of 19 is 12.5. My emails went unanswered until my Area directed me to contact him a third time and report the results to them. He then finally responded saying there were only 20 voting members present, one was an abstention, and 12 was 2/3 of 19. I did not respond to that email, as it was then insinuated that I, or my Area, took personal issue with Gene, which is simply not the case. The Guidelines are clear that only votes in favor are counted in elections, making an abstention essentially a "no" vote. However, the Chair at no time asked for abstentions. When I took the response from the Chair to my Area this month they asked that I ask for a new vote.

Pikes Peak is doing well. The GSRs are still meeting and having a monthly GSF. Some of our meetings have slowed down, but I think that is the natural occurrence in the summer and suspect it will turn around soon. There is a new meeting in Trinidad that has decided to join our Area, New Solutions, which meets Monday and Saturday 7:30 pm – 8:30 pm at the Trinidad Alano Club, 120 W. Kansas Avenue. We also have a new meeting in Green Mountain Falls, called Mission Possible which meets Tuesdays 7:30 pm – 8:30 pm at the Red Cloud Serenity Club at 10400 Ute Pass Avenue. We are excited to see the Area growing! The Women's Retreat (which is hosted-in part-by the Sisters in Recovery group of Pikes Peak) was a huge success. They really appreciate your support in allowing them to raise funds and provide lunches at the business meetings. Planning for the third retreat has kicked off! WRCNA III is in need of a Web Servant and an F&E Chair.

The only event in Pikes Peak in October is the CRCNA fundraiser: Mexican Dinner and bingo. The event will be October 24 at 2221 N. Wahsatch Ave, Colorado Springs, 6 pm – 11 pm. The cost is \$10 and covers dinner, a drink, and 5 bingo cards. You may purchase extra bingo cards. There will also be a green chili cook-off.

### SERENITY UNLIMITED :

We had a good meeting last weekend in Moab, Utah. It was a beautiful drive over on the River Road, with fellowship along the way.

Area members that helped out at the State Fair received a thank you from the Area Service Committee. Speaking of service, it has become a large focus of the Area's drive to continue the upswing of attendance and recovery here on the Western Slope.

Goals:

1. Compile current regional data for all of the facilities we serve and the number of volunteers available
2. Assemble H&I Regional Subcommittee. I would like to meet with all area chairs possibly sometime during CRCNA and discuss this process and regularity of meetings. I am most definitely open to guidance in this area.
3. Personal commitment to H&I service.
4. This is probably not an immediate goal, but I would like to increase our presence in Colorado hospitals.
